Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

Located east of the Warfield Group and north of the water tank, the Locomotive House is a one and a half story, flemish bond brick building. It measures four bays wide and two bays deep. A stone foundation supports the brick building and slate tiles cover the gable roof. The building is symmetrical.

The east and west walls each display two windows which have been sealed with plywood. The openings show smooth stone sills and brick vertical joint lintels. A simple boxed cornice rests below the slate roof.

The southern and northern walls exhibit the gable end of the building detailed by a plain boxed cornice. An oculus window appears just below the peak of the gable. A circular stone lintel is interrupted by raised keystones at each quarter mark. The openings do not show any glass. The northern facade exhibits a single recessed door with a stone sill and a brick vertical joint lintel. In contrast, the southern wall displays a large vertical board stable door. The face of the gable is covered by corrugated metal. Ivy vines grow on all four brick walls.

Prepare both a summary paragraph of significance and a general statement of history and support.

As mentioned in the Biennial Report of the Board of Managers of Springfield State Hospital, a brick locomotive house, including necessary switch connections had been built between 1913 and 1915. The construction of the locomotive house increased the efficiency of the railroad operation at Springfield. The existence of the railroad at Springfield was considered essential to the smooth operation of the hospital. When the Board Of Managers of the newly authorized hospital began scouting for an appropriate site for the facility in 1896, one of the requirements of the location was its easy access to railroad transportation. Because the hospital was going to be located in the country, a railroad line would be necessary for the quick transportation of goods and materials. When the Board of Managers chose the Springfield farm as the new hospital site, the Baltimore and Ohio railroad line passed through Sykesville so that only a short rail extension would need to be laid between Sykesville and the new hospital site. The construction of the locomotive house was an improvement of this rail line by 1915.

It is most likely that the building was erected by hospital personnel and patients. The design of the building is simple but defined. The flemish bond brick, oculus windows and the slate roof combine to provide the building with a clean, symmetrical appearance which continues to display its workmanship and design.
