The Richard A. Murray House was built about 1900 and is representative of the early 20th century houses in Carroll County that retain Victorian period characteristics. This two and one-half story structure with a T-shaped plan includes popular Victorian ornamentation such as the wrap-around porch with spindle and bracket trim, patterned shingles on the front gable, and a slate roof.

Situated on ~~Main~~ street in Hampstead, the Richard E. Murray house is a two story building of brick construction with a fieldstone foundation. The house is T-shaped although a kitchen was added in 1949. The house didn't even have a bathroom until 1946. The roof is in good condition and is made of slate. The house has two fireplaces with one brick chimney. There is a roofed porch on the second floor in the back. There are four different entrances to the house, including the door leading to the 2nd floor porch. The first story of the front of the house is surrounded by a porch on three sides with a tin gabled roof. There is a great deal of wooden ornamentation just below the roof of the porch. There are also Victorian shingles that decorate parts of the house. The floors are all wood. The house has been altered since its building. There used to be a long hall off the front door but there is now a living room. The original staircase was much too steep and had to be altered. There has also been four feet added to the dining room. The house was built around the turn of the century by Richard E. Murray.

The Murray family was a prominent family in Hampstead economically and socially around the turn-of-the-century. There is proof that the Murray family settled on the Easter shore.

Thomas J. Hunt sold a 1.75 acre lot to Richard E. Murray July 25, 1895. (81/277) According to oral tradition, there was a small house on this lot that was replaced by the existing one. The existing house was built by Richard E. Murray around the turn of the century and was eventually sold by Harvey E. Murray to Bernard Sievert for \$18,400.00 on July 21, 1947. Kathy Sievert now lives there.

The house has been altered a great deal by the Sieverts since its building. The dining room has been enlarged by four feet and the original staircase was also altered. There was also a kitchen added on around 1949.

The interior and exterior are in good condition and are a good example of the architecture common to this period.


