The Sallie and Samuel Sterner (Starner) House was for much of the late nineteenth century owned by the Reindollar family, and was apparently a tenant farm. The farm was purchased in 1887 by John H. Sterner. He already owned a 145-acre farm and probably bought this to set up his children. The 116-acre farm was sold to Sallie F. and Samuel P. Sterner in 1895. The improvements on the farm were worth only \$550 in 1896. Two years later the Sterners had added a new shed and stabling worth \$300. The new house was built by 1899. For unknown reasons, the Sterners sold the farm in 1903. The elaborate exterior trim on the house is rarely found in Carroll County. This is a particularly fine, and well-preserved, example.

### Summary:

The Sallie and Samuel Sterner (Starner) House is located at 3921 Bullfrog Road, on the east side of the road in northwest Carroll County, Maryland. The house faces west toward the road. It is a five-bay by two-bay, 2½ story frame structure. The west elevation has a center entrance. On either side are new 1/1 sash with blinds and a pediment with jigsawn foliate trim. There is a bracketed cornice with jigsawn trim and a central gable dormer with diamond-pattern shingles. There is a one-story, three-bay porch centered on this elevation. It has four turned posts and a jigsawn frieze.

The Sallie and Samuel Sterner House is located at 3921 Bullfrog Road, on the east side of the road, about ¾ miles northwest of Taneytown and about ¼ miles southwest of Harney in northwest Carroll County, Maryland. The house faces west toward the road. It is a five-bay by two-bay, 2½-story frame structure with a parged foundation, aluminum siding, and an asphalt shingle gable roof with a north-south ridge. There is an interior brick chimney on the north end and appears that there was once one on the south end, too.

The west elevation has a center entrance. The top half of the door has a large central panel flanked on each side by a narrow rectangular panel, and at each corner by a small square panel, making nine panels in all. Below are two panels. They are sunk fielded panels with small panel moulds that appear to have an ogee with a cavetto inside of it, but are not sharply defined. There is a one-light transom. On either side are two new 1/1 sash with blinds and a pediment with jigsawn foliate trim. There is an ogee moulding along the top edge of each pediment. The second story has five identical sash with pediments and trim. There is a bracketed box cornice with returns and with jigsawn trim in a sideways lyre pattern on either side of each bracket. Between this trim is jigsawn foliate trim in the frieze, centered over each pediment. There is a central gabled wall dormer with diamond-pattern shingles and a pedimented 1/1 sash. Both the bed mould and raking eave of the dormer have a sawtooth moulding. There is a one-story, three-bay porch centered on this elevation. It has a hip roof and four turned posts. Between each pair of posts are two pendant drops. Between the drops is a frieze with a jigsawn rinceau at the top and spindlework below. Between each post and drop is a jigsawn frieze with a quatrefoil, and a jigsawn bracket below it. There are also sawn brackets projecting from the top face of each post.

The north elevation has two 1/1 sash on both the first and second stories that are identical to those on the west. The gable end has two small 1/1 sash that also have pediments. There is a dentil cornice in the raking eave. The east elevation has an addition to the north and a one-story porch with a shed roof and Doric columns to the south. The south elevation has a hurricane door in the east bay of the foundation. The rest of the elevation is identical to that on the north.

The house on this property was apparently roughcast. The farm was purchased in 1887 by John H. Sterner for \$3,050.00. He already owned a 145-acre farm and probably bought this to set up his children. The 116-acre farm was sold to Sallie F. and Samuel P. Sterner in 1895 for \$3,000, but they were probably working the land since 1887. In 1896 they owned livestock worth \$255, a grain thrasher, a clover huller, and most unusual, a traction engine and wagon. The results of their experiment with modern farm machinery apparently was not satisfactory, as they had disposed of the first two machines by 1899 and the traction engine by the following year.

The improvements on the farm were worth only \$550 in 1896. Two years later the Sterners had added a new shed and stabling worth \$300. The new house was built

by 1899, and was valued at \$800 plus the value of the old house, or probably about \$1,000 in all. For unknown reasons, the Sterners sold the farm in 1903; it now brought \$3,700, indicating that it had been improved. The farm apparently remained in operation until the early 1970's, when the house was broken off from it. The elaborate exterior trim on the house is typical of late-nineteenth century trends, but is rarely found in Carroll County. When it is found, it is most often used in towns and not on rural houses. This is a particularly fine, and well-preserved, example.






