Justification for decision: (Use continuation sheet if necessary and attach map)

The Barbara Slaughenhaupt, located south of Taneytown in rural Carroll County, MD, and consisting of a small farm complex, is not considered eligible for individual listing on the National Register of Historic Places. The property is outside of a potential Taneytown Historic District; however, along with other farmsteads in the vicinity, the property could contribute to a potential rural historic district. At this point, no examination of the area for rural historic district designation has taken place.

The property is composed of a mid-19th century log farmhouse with three frame additions; a frame summer kitchen and associated structures; a frame barn with associated structures and other non-contributing secondary resources. The farmhouse is a 2-1/2-story, four-bay, double-pile log house clad with aluminum siding. The house features a two-door facade, indicative of the "Pennsylvania Farmhouse Type." It is covered with a gable roof and has several frame additions, including a side and rear, one-story wings. The front porch which extends the width of the house is not original, nor is the brick wall forming its edge. Behind the house is a three-bay summer kitchen with weatherboard siding and 6/6 windows. The frame barn, behind the summer kitchen, is a large two-story frame structure with attached sheds and characterized by its louvered openings with scroll-sawn decorative trim.

Although the property provides a cohesive grouping of domestic and agricultural buildings, the individual elements making up the whole lack the distinctiveness necessary to qualify for listing under Criterion C. The house, due to its vinyl siding and later additions, does not provide a particularly representative example of a log dwelling, and the barn, though a good late 19th-century barn with attached dependencies, has a non-historic opening (garage door) in the original fabric. The property thus lacks the architectural integrity necessary to qualify it for the National Register.

The Barbara Slaughenhaupt Farm consists of a mid-nineteenth century log farmhouse, a frame summer kitchen flanked by a frame shed and a frame machinery shed with an attached granary, a concrete block summer kitchen, a frame barn with side shed, a machinery shed, and a large poultry house. The farmhouse is a two-and-a-half story, four-bay, double-pile log house. The house has two doors on the facade, a from which has been labeled as the "Pennsylvania Farmhouse Type" and which is seen as the mingling of the formal Georgian plan and symmetry with the traditional three-bay German farmhouse. The barn features louvered ventilators with pediments and decorative trim. The Barbara Slaughenhaupt Farm appears to be eligible for inclusion on the National Register of Historic Places under Criteria A and C. The farm is a well-preserved farmstead with buildings dating from the mid-nineteenth through the early twentieth century. The farm buildings reflect the mixed agriculture practiced within the community, and the small scale farming pursued on this farmstead. The double-pile farmhouse with the two doors on the facade is a common mid-to-late nineteenth century vernacular form found in areas with settlers of German ancestry or in areas where the settlers have migrated from regions with a German heritage. The farmstead retains the integrity of location, setting, materials, workmanship, feeling, and association.

The Barbara Slaughaupt Farm is composed of a mid-nineteenth century log farmhouse with three frame additions, a frame summer kitchen flanked by a frame shed and a frame machinery shed with an attached granary, a concrete block summer kitchen, frame barn with side shed, a machinery shed, and a large poultry house standing on 8.282 acres.

The farmhouse is a two-and-a-half story, four-bay, double-pile log house with three additions: a one-story wing on the west elevation, and two one-story frame rear ells. The house is sided with aluminum and has some original six-light sash and some replacement single-light sash. A one-story shed roof porch with modern posts and brick balustrade covers the front facade. The double-pile house has two doors on the facade, a form which has been labeled as the "Pennsylvania Farmhouse Type" and which is seen as the mingling of the formal Georgian plan and symmetry with the traditional three-bay German farmhouse (Henry Glassie, "Eighteenth-Century Cultural Process in Delaware Valley Folk Building," in Upton and Vlach, 408).

To the southeast of the house is a three-bay summer kitchen with weatherboard siding and six-over-six light sash windows. Attached to the north end of the kitchen is a frame wood shed. To the south end of the kitchen is a frame shed, attached to which is a granary for storing corn on the ear. A concrete block kitchen with a gable roof stands to the south of the house.

A frame barn stands south of the house and features louvres with pediments and decorative trim. An overhead garage door was added to the west end of the north elevation. A side shed was constructed on the west elevation of the barn. To the west of the barn stands a large machinery shed, and a poultry house oriented to the southeast.

The Barbara Slaughenhaupt Farm is a well-preserved farmstead with buildings dating from the mid-nineteenth through the early twentieth century. The farm buildings reflect the mixed agriculture practiced within the community, and the small scale farming pursued on this farmstead which has ranged from just over two acres during late nineteenth century to a little more than 20 acres during the early twentieth century. The double-pile farmhouse with the two doors on the facade is a common mid-to-late nineteenth century vernacular form found in areas with settlers of German ancestry or in areas where the settlers have migrated from regions with a German heritage.

The Barbara Slaughenhaupt Farm was part of the 1754 land grant, "Resurvey on Brother's Agreement." The farmhouse appears on the 1862 map of Carroll County as the property of Miss Slaughenhaupt (Simon J. Martenet, "Martenet's Map of Carroll County" Baltimore: Simon J. Martenet, 1862), and on the 1877 map as occupied by Barbara Slaughenhaupt (Illustrated Map of Carroll County (Philadelphia: Lake, Griffing & Stevenson, 1877)).

Barbara Slaughenhaupt purchased two tracts of land from Samuel and Frances Newcomer in 1858, a 3/4 acre lot and a 1 1/4 acre lot for a total of \$104.70 (Carroll County Land Record Book 70: 462; 70: 463). Slaughenhaupt sold the house and land to Obadiah Fleagle in 1890 (CCLRB 81: 20). The property remained the two tracts until the early twentieth century when a third tract of 18 1/4 acres was added to create a property of 20 acres and 119 perches (CCLRB 141: 437). The farm remained 20 acres until 1973 when Ferdinand and Margaret Lauterbach sold the house, outbuildings and 8.28 acres to William Lohr (CCLRB 543: 178).






