Summary:

The small town of Millers owes its existence to the constuction of the Hanover branch of the Western Maryland Railroad in 1877. Just as the arrival of the railroad spurred development in nearby Hampstead, construction boomed around other stations along the line, even when those stations were placed nowhere near any settlement, as with Millers. George P. Miller owned the land on which the station was built, and created building lots around it some time afterward. he sold the $\frac{1}{4}$ acre lot as 3500 Young Road to George Diese and John K. Miller for \$60.00 in 1883. Even before the execution of the deed, a Westminster newspaper noted that "Miller & Dise's [sic] cigar factory will be erected as soon as the weather is fit to continue outside work. They commenced digging the foundation last Tuesday."

The Miller Cigar Factory is located at 3500 Young Road at the southwest intersection of this road with Miller's Station Road in the settlement of Millers in northeastern Carroll County, Maryland. The house faces northeast toward Young Road and is a 2 story three bay by two bay frame structure with a rubble-stone foundation; aluminum siding and a gable roof of standing seam metal with a northwest to southeast ridge. The house has a center entrance plan. The northeast elevation has a four panel door with a transom on the first story and a 2/2 sash on either side of the doorway. The second story has three 2/2 sash. There is a 1 story three bay porch with a half hip roof of standing seam metal; four chamfered posts and jigsaw brackets. The porch has a new balustrade. The southeast elevation has a cellar bulkhead in the foundation in the south bay. The first and second stories each have two 2/2 sash and there are two small 2/2 sash in the gable end. There are interior brick chimneys on both the southeast and northwest gable ends. There is a three bay by one bay 1 1/2 story ell attached to the southwest elevation. The ell is unusual in that it has a shed roof that slopes down to the northeast. The southeast elevation of the ell has a full 2 story profile. There are three short 1/1 sash on the first story and three tall 1/1 sash on the second story. The southwest elevation of the ell has no openings. There is a modern addition in the southwest crook formed by the main block in the ell. The northwest elevation of the main block is identical to the southeast elevation. Moved to elsewhere, the northeast elevation has a central gabled wall dormer with a semi-circular arched 2/2 sash. The transom has three lights and the door has four belection moulded panels.

The first story has a center entrance vestibule with an enclosed stairway that runs up to the southwest. The house has a single pile plan and originally had one room in the ell. The east room is the most significant as wallpaper was recently removed from the walls revealing original or early stenciling and paint. The walls are painted brown and have stenciling along the freeze of a yellow oaker and several shades of green. There is also a border along the ceiling with a stylized floral pattern employing the same colors. In the center of the room is a compass design on the ceiling. The architraves are plain head-cut trim with the top piece pedimented but with no mouldings applied. In the center of the southeast elevation is a wood mantel piece that has chamfered pilasters with applied panels and a tutor arch between them. The freeze is plain and has applied cartouches above each pilaster. There is a simple beveled bed mould and the mantel shelf has a scallop cut to it. This was never a functioning fireplace but was always constructed for a stove. The north room apparently originally functioned as the kitchen but has been greatly altered. The ell room walls and ceiling are covered with beaded-edge-in-center boards that are painted. Part of the room has been enclosed to create a bathroom and part of the ceiling has been removed to create a loft. The second story plan mirrors the first story. Contributing resources 1.

Even before the execution of the deed, a Westminster newspaper noted that "Miller & Diese's [sic] cigar factory will be erected as soon as the weather is fit to continue outside work. They commenced digging the foundation last Tuesday."

The year 1883 was a busy one for the new settlement of Millers, which was known at the time as Tank Post Office, apparently because a water tank for locomotives was located nearby and the post office took its name from this. In September of that year, a correspondent to the Westminster newspaper wrote:

Our community is rapidly increasing. John Miller, J. Barnhart and R. Hoffnagle are building new houses; Henry K. Miller and George Barber intend to build either late this fall or next spring... Louis Redding's new building is in a fair way of completion. Augustus Redding has weather-boarded his dwelling house and is making preparation to paint it.

Presumably, the new house John Miller was building was this cigar factory. While George Diese was a partner in the operation, he sold his share to Miller in 1885 for \$600. Miller retained the property until 1931.

The building that Miller and Diese constructed was a dwelling with a manufacturing room attached to the rear. The house was very typical of residential architecture of Carroll County in the 1880's, especially for towns in this area. A traditional three-bay, center entrance, single-pile plan was used, and given a "modern" treatment by the addition of a central gabled wall dormer and jigsawn porch brackets. These features were also very popular at this time. The rear wing reads as a typical kitchen ell, but is unique in its use of a shed roof. The interior is finished with beaded-edge-and-center boards on the walls and ceiling. This is unusual for housing, but it is impossible to say at this time whether the treatment was common for small factories, or even if there were many such factories attached to dwellings, such as this.

An early photograph of the building shows that the first story openings on the factory have been reduced in size, and the door converted to a window. The windows

were covered by shutters, probably to prevent burglaries. the rest of the windows did not have shutters or blinds. Like most dwellings of this period, Miller's house had a wood shingle roof. The most significant feature of the house, however, is the recent discovery of original or early paint finishes in the parlor, or primary room, beneath later wallpaper. The room was painted a medium, yellow-brown, with a stenciled frieze and a stenciled band on the ceiling. the stencils are primarily a forest green and a light green, with some dark brown and iron-oxide red, as well. There was a long tradition of the use of stencils in Carroll County dwellings of the nineteenth century. The patterns and colors chosen by Miller are not traditional, however, but are clearly influenced by the Aesthetic movement. Survivals such as this are extremely rare, and considering the age and history of these finishes, they are in relatively good condition. Their future, however, is in question.


