Summary:

The Hann-Warner House is the southern-most of three brick houses that were virtually identical when first built. Originally part of the land of Jacob Caltrider, Jr., who lived next door at 1440 North Main Street, Caltrider's property was turned over to a trustee who sold off numerous lots. The lot for 1502 North Main Street was purchased at a public sale in February 1878 by E. Benton Hann for \$100. The deed was not executed until February 1879, at which time Hann was assessed for the lot. Two years later Hann was assessed for the 55 acre farm of George L. Warner, and a new barn. That same year, 1881, Hann deeded to George L. Warner his Hampstead lot for \$1500. In 1882 Warner was assessed for the lot and a new house valued at \$1000. Clearly Hann built the house, but did not own it for long. Whether he ever lived here is not known. It is possible that Hann was hired by Warner to build it, or built it on spec and sold it. Warner could have purchased it as early as 1879, with the payments spread out for two years, as was customary with real estate transactions. In any case, Warner himself did not own it long, deeding the property to John M. Blocher in August 1884 for \$1700. Blocher died a year later but his widow, Sarah, continued to live here until her death. It then passed out of the family in 1905.

The Hann-Warner House is located at 1502 North Main Street in Hampstead in northeastern Carroll County, Maryland. The house is located on the west side of the street and faces east toward the street. It is the southern most of three brick houses that were originally identical. The house is a 2 ½ story three bay by two bay structure of running bond brick on the east elevation and five to one common bond brick on the remaining elevations. It has a rubble stone foundation and a gable roof of asphalt shingles with a north/south ridge. There is an ell on the west elevation that is 2 stories and two bays by two bays. It is also of brick and has a gable roof with an east/west ridge. On the east elevation, the first story has a center entrance with a glazed door with 1-light side lights and a 5-light transom. The doorway is flanked by a Queen Anne 1 1/1 sash in a widened opening on either side. There are traces of penciling here and the paint work is executed in such a way as to make it appear that there are voussoirs over the whole opening rather than just the original part of the opening. There is a three bay 1 story porch with a hip roof of standing seam metal. It has piers with shingles that support four dorricks columns. There are shingled balustrades between the piers. In the center of the porch is a pediment with shield shaped shingles. The second story has three 2/2 sash with splayed brick jack arches. There is a wood box cornice with a bed mold that appears to be a belectioned molding. There is a central gabled wall dormer with a lancet shaped 4-light sash and a brick label mold. There is an interior brick chimney on both the north and south gable ends. The north one is paneled. There is another paneled chimney on the west gable end of the L. The north elevation of the main block has two 2/2 sash on both the first and second stories and two 4-light sash in the gable end. The ell has one 2/2 sash on both the first and second stories. On the south elevation, the main block has two 2/2 sash on both the first and second stories and two 4-light sash on the gable end. The ell is set back one bay. The west bay has a pantry with a 2/2 sash on both the first and second stories. The east bay has a recessed porch with infill on the first story and vertical balusters on the second story.

West of the house is a summer kitchen. It is a 1 ½ story two bay by one bay frame structure with German siding and a gable roof of standing seam metal with an east/west ridge. There is an interior brick chimney on the west gable end. On the east elevation, the first story has a 6/6 sash and a six panel door. The gable end has a 4-light sash. The south elevation has a new shed added to it.

The Hann-Warner House is typical of the many houses built in the decade after the railroad came to Hampstead in 1877, and was likely a result of it, too. The three-bay, 2 ½ story dwelling with a central gabled wall dormer became ubiquitous in Hampstead. More commonly of frame, this is a brick example with a nice label mould over the lancet window in the dormer. The first story was altered; most likely in the period C. 1905-1915. The central doorway was opened up to give it sidelights and a transom, as well as a new door, and the windows flanking it were also enlarged and replaced with stained glass Queen Anne sash over a single light. The porch was also rebuilt, with Doric columns set on wood-shingled piers and a pediment in the center that contains shield-shaped wood shingles. This is an unusual shingle pattern that can be seen in at least one other Hampstead house, but has not been observed elsewhere in Carroll County.


