DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This is a small rural church of brick construction one storey in height with an "A" frame roof running E-W. The facade, E end elevation, displays three bays, viz, center door flanked by a larger window to ea. side (lancet). The eave moulding is of brick in a very shallow dentil. Above the E door is a round diamond framed stained window with a small plain circular window above that. ~~Stairs~~ and ugly spire shaped corner "buttress" containing stone flues are at ea. front corner rising from ground level to a height ~~even~~ even with the roof ridge.

Carr 176 - a house situate in close proximity to the church is of English bonded brick, one storey with an "A" frame roof running N-S. with the facade at the W. wall. Eaves decorated with a brick sawtooth dentil pattern.
