Milestone No. 69(72) is an original monument of 1767 at its original site, marking Mason and Dixon's 69th horizontal mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line, longest of their survey lines run and marked during their 1763-68 commission to define the boundary between the English provinces of Maryland and Pennsylvania. As with all original West Line monuments, this milestone was quarried and carved in England, of oolitic limestone, measuring about 12" square by about 4 1/2' long, cut to stand as a post about 3' above ground with the base left rough-cut for setting into the ground. It is embellished with vertical fluting and horizontally-fluted margins on all four sides, with a fluted low pyramidal top rising about 2" to a centered apex. The distinguishing features are the Roman capital letters P on the north side facing Pennsylvania and M on the south side facing Maryland, each V-sunk into a plain shallow circle panel near the top. In 1902, during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary, No. 69(72) was reset to stand about 1 1/2' high and surrounded below ground with a concrete collar. It now stands about 1' high, measures about 11" square, and all surfaces are very weatherworn, mottled by lichen and darkened from periodic flooding. But most embellishments remain distinct and comparatively intact. On the federal and state levels, this milestone is significant primarily as one of the series of 135 original monuments still standing along the West Line, the boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. Locally, as one of 18 original monuments marking the present Carroll/York-Adams county boundary (3 crownstones; 15 milestones), it is also significant as one of a diminishing number of objects and structures with a visually identifiable relationship to the colonial and Civil War heritage of these counties.

Milestone No. 69(72) marks Mason and Dixon's 69th horizontal mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line. It is an original milestone, ^{set in 1767} at its original site preliminarily surveyed in 1765; is in good condition, unaltered and still firmly in place, as reset in 1902 during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary.

The area here is rural, rolling, sparsely settled. The site is within Election District 3 of Carroll County, MD, Germany Township of Adams County, PA; about 1.7 miles due south of ^{the town of} Littlestown, PA; about 1100 feet south of Georgetown Road with its scattered settlement called Georgetown; on the north side of an old east-west wire fence and about 185 feet west of its junction with an old north-south wire fence; in a ^{marshy} tangle of scraggly deciduous woods/honeysuckle/briars/multiflora, at a point about 300' north of a small stream. It cannot be seen from any road, nor easily from closeby any season, and is thus protected by the site's obscurity and the fence.

As with all original Mason and Dixon West Line monuments, this milestone is an embellished, oolitic limestone post with a low pyramidal top; was quarried and ~~carved~~ ^{carved} in England, measuring about 12" square by about 4½' long, cut to stand about 3' above ground with the base left rough-cut for securing below ground. There is vertical fluting and horizontally-fluted margins on all four sides, with fluted planes rising about 2" to a centered apex. The distinguishing features are the Roman capital letters P on the north side facing Pennsylvania and M on the south side facing Maryland, each V-sunk into a plain shallow circle panel near the top. Reset in 1902 to stand about 1½' above ground, No. 69(72) now stands about 1' high, ^{measures} about 11" square and all surfaces ^{are} very weatherworn as well as ^{mottled by lichen and} darkened from periodic flooding. But most embellishments remain distinct and comparatively intact, with only minor chips at the top corners and edges.

The site was preliminarily surveyed in 1765^{and} monument set in 1767, where it remains unaltered to this day, although reset more securely in 1902 during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. Locally, as one of 18 original monuments marking the present Carroll/York-Adams county boundary (3 crownstones; 15 milestones), No. 69(72) is also significant as one of a diminishing number of objects and structures with a visually identifiable relationship to the colonial and Civil War heritage of these counties.


