Milestone No. 73(76) is an original monument of 1767 at its original site, marking Mason and Dixon's 73rd horizontal mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line, longest of their survey lines run and marked during their 1763-68 commission to define the boundary between the English provinces of Maryland and Pennsylvania. As with all original West Line monuments, this milestone was quarried and carved in England, of oolitic limestone, measuring about 12" square by about 4 1/2' long, cut to stand as a post about 3' above ground, with the base left rough-cut for setting into the ground, and capped by a low pyramidal top. It is embellished with vertical fluting and horizontally-fluted margins on all four sides, with the fluting carried up the top planes to a centered apex. The distinguishing decorative features are the Roman capital letters P on the north side facing Pennsylvania and M on the south side facing Maryland, each V-sunk into a plain shallow circle panel near the top. In 1902, during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary, this milestone was reset to stand about 1 1/2' above ground, as it does to this day. It remains in good condition, unaltered, and with most embellishments clear and fairly intact, except for large chips on the south side and all edges and top corners, and noticeable weathering of the top, now almost flat. On the national and state levels, No. 73(76) is significant primarily as one of the series of 135 original monuments still marking the West Line, the boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. Locally, as one of 18 original monuments marking the present Carroll/York-Adams county boundary (3 crownstones; 15 milestones), it is also significant as one of a diminishing number of objects and structures with a visually identifiable relationship to the colonial and Civil War heritage of these counties.

Milestone No. 73(76) marks Mason and Dixon's 73rd horizontal mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line. It is an original monument of 1767, in good condition, unaltered, and at its original site, though reset in 1902 during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary.

The area here is farmland, sparsely settled, open except for the woods following Alloway Creek <sup>close by</sup> and its tributaries. The site is within Election District 1 of Carroll County <sup>MD</sup> Germany Township of Adams County, PA; a little over 2 miles east northeast of the towns of Harney, MD; <sup>at a point</sup> about 800' east of Alloway Creek and about 700' north of the end of Frock Road, in the middle of a flat finger of farmland surrounded by Alloway Creek (on the north and west) and a small tributary (on the south). It cannot be seen from any road, but easily from nearby when vegetation is dormant and crops have been harvested.

As with all original Mason and Dixon West Line monuments, this milestone is an embellished oolitic limestone post with a low pyramidal top; quarried and carved in England, measuring about 12" square by about 4½' long, cut to stand about 3' above ground with the base left rough-cut for setting below ground. There is vertical fluting on all four sides, edged with horizontally-fluted margins, and with fluting carried into the top planes which converge at a centered apex. The distinguishing decorative features are the Roman capital letters P on the north side facing Pennsylvania and M on the south side facing Maryland, each V-sunk into a plain shallow circle panel near the top. In 1902 this milestone was reset to stand about 1½' high, as it still remains. There has been considerable chipping by farm machinery recently, especially on the south side <sup>into the letter M</sup> and all edges and corners. Although protected from the public it is not marked and very vulnerable to damage by machinery working the field. Otherwise, the embellishments remain clear, except for weathering of the top and west side.

Milestone No. 73(76) is significant on the national and state levels primarily as one of the series of 135 original Mason and Dixon monuments still defining their <sup>230.228-mile</sup> West Line, the boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. The site was preliminarily surveyed in 1765 and monument set in 1767, where it remains unaltered in its original site to this day, although reset more securely in 1902 during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. Locally, as one of 18 original monuments still marking the present Carroll/York-Adams county boundary (3 crownstones; 15 milestones), No. 73(76) is also significant as one of a diminishing number of objects and structures with a visually identifiable relationship to the colonial and Civil War heritage of these counties.


