DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

A six bay house the Trevanion Road House is situate on the W. side of said road approximately two miles S. of Taneytown, is of brick construction and two storeys in height. At the ground level, E. elevation, front, the window and door arrangement is as follows (from SE corner): W.W.D.D.W. with six windows at the second level.

The facade of this dwelling is stucco over brick while the N. end has its brick exposed and the S. end is sheathed in clapboard. A rear wing runs out from the W. elevation of the main block with its N. wall flush to the NW corner of the Main block. On its S. elevation the wing has a two storey porch.

The main block has an A frame roof running N to S and possesses an interior chimney at each end. To the E. elevation (front) is a one storey farm porch with interesting Victorian mouldings.
