

Emmanuel Baptist, originally built as Mount Pleasant M.E. Church in 1872 and turned over to the former in the 1940's, was organized because of the Methodist split in the late 1830's. Until this rectangular uncoursed stone church was built the congregation worshipped in a log structure on the same property.

 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Old Mount Pleasant Methodist Church faces north/east off of Sykesville Road, and sits upon a small hill thirty or so yards from it. The facade faces Finksburg, the back, Eldersburg.

The wall structure and foundation are of uncoursed stone of this three-bay front, four-bay side, small rectangular building. Windows are rectangular in shape with plain trim and contain stained glass. Stone, rectangular bases anchor each window. The wood gable roof is covered with what appears to be sheet metal shingles and ends in a box cornice. A central, exterior end, back wall chimney has battlement-type open brick work. It appears to be more recent than 1872 and is in great need of repair.

A square belfry with rounded arch openings is covered with painted wood shingles. It has a simple turned railing around it and is topped by a hip-style roof with extended ends.

The southern back wall is void of windows, but has a recent entrance door.

The north/east front facade has two entrance doors on either side of a central stained glass window. Above this window and below the gable is a round, stained glass window that reads "Mount Pleasant Methodist Church". The entrance doors are reached by a large, single, stone step. They are each large, double two-panelled recessed wood doors with plain wood trim and stone lintel, Above the lintel are stained glass transoms. Cement steps and platform porch lead to these entrances.

A contemporary building which houses an auditorium, Sunday School rooms, kitchen, etc. connects with the church by an open breezeway. The church sits among trees, with its own cemetery in back.

STATEMENT OF SIGNIFICANCE

The Methodist/Baptist Church not only stands as one of the few remaining stone chapel/church in the county, but also as a structure identified with the Methodist split over church issues in the 1820's - 30's in this area.

Robert Strawbridge came to Maryland and the New Windsor area as the first pioneer of America Methodism (see CARR. -86). But other pioneers came directly from Wesley in England to plant Methodism and expand it in this country. In the late 1700's, Methodism came to the Gamber area via Robert William, a convert of Wesley's, from England, settled here and erected a sod house for worship and preaching. The congregation grew rapidly and in 1827 land was purchased and the Providence Meeting House was to be built. Because of heated arguments over church issues, the Methodist split. A decision could not be made between church self-government and equal rights for laity and clergy. The land and then log house, was given to the supporters of equalization, the "Methodist Protestants". The "Methodist Episcopalians" who favored more authority for their bishops, moved out. The split was named the "Providence Split".

The Methodist Episcopalians worshipped for over ten years, first in an old school, then in a Louisville (neighboring community) shed. Finally they had a log structure on the present Sykesville Road (Md. 32).

At this time, 1843, the church was incorporated and well-organized as the Mount Pleasant Methodist Episcopal Church. In 1872, they erected this stone church on the same spot and parcel of land. In 1943, Providence and Mt. Pleasant merged at last to form one congregation again. The church now stands as the home of Emmanuel Baptist Church.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Originally known as the Mount Pleasant M.E. Church this structure is rectangular in shape and of cut field stone construction.

At the N. ~~to~~ end elevation, facade are two doors flanking a centered window. The two doors are recessed and possess traceried transoms with stained panes. The window is one over one sash with leaded tracery. There is a fully round window at the gable level.

Both E. and W. elevations are four windows in length with one over one sash containing stained leaded glass.

The roof is A frame running N to S. with the interior N end belly of frame construction and possessing lancet openings. There is a small interior stove chimney at the S end.

At the eaves are shallow boxed cornices with gable returns.

To the W. elevation is a recently constructed cinder block parish hall.
