DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Early 19th. century with unusual door and window arrangement. The front and rear each has 2 center doors with three light transoms above flanked by 1 window: ~~at window-door-door-window~~. There are 2 windows on the second floor level each corresponding to the window placement below.

Main block is brick, two story, no additions with the exception of front and rear porches presently being constructed. The original porch over doors gone. House has center hall, is 2 rooms deep, fireplaces at each gable end, window panes 6/6, 6 windows ea. gable end ² for ea. floor incl. attic. Eaves boxed and all mouldings plain.

NOTE: A short distance from the house is a smaller cabin type dwelling of stone and frame with large chimney. This building is too far away to be an enlarged kitchen and may have been the original house as it seems to predate the larger dwelling.
