Summary paragraph:

The house is a two-and-a-half story, three bay by four bay asbestos shingle sided structure. The complex contains the house, a small barn, a summer kitchen a frame outhouse and a frame outbuilding.

Description

House (1820-1860)

The house is a 2-1/2 story, two bay by three bay structure sheathed in asbestos shingle siding. The metal gable roof is perpendicular to the road with an interior, central brick chimney [originally on west end prior to addition]. Fenestration is irregular with six-over-six wood, double hung windows on all elevations except for the second story, principal [south] facade. Here two 4 lite windows are visible in the southwest corner. Two entries are located on the principal facade and an open porch with square posts and metal shed roof extends across the facade.

A 2-1/2 story, three-by-two-bay addition is affixed to the main block's west elevation. The metal gable roof is perpendicular to the road and cornice surrounds are visible on the west gable end. Six-over-six windows are visible on all elevations, the upper story of the principal [west] facade contains a rounded arch two-over-two window. An open porch with wrought iron posts and a metal shed roof extends across the west facade and along the south elevation. The front gable entry is common in the Pennsylvania/Maryland areas but examples in the project area have been limited. The addition's minimal Greek Revival-style expression diverges from the norm in the project area.

Barn (1820-1840)

The two story, English barn is located northwest of the main house. The frame, two bay by three bay barn has a metal gable roof perpendicular to the road.

Outbuildings (1820-1860)

The one-and-a-half story summer kitchen is affixed to the east elevation of the main block. Sheathed in asbestos siding, the two bay by two bay, structure has a metal gable roof and an exterior brick chimney at its east elevation.

Two small frame barns are located behind the main house and south of the barn, their function cannot be identified at this time. The southernmost of these barns has a metal chimney flue on its south elevation. A frame outhouse is also part of the farm complex.

8. Significance

Summary paragraph:

This farmhouse was constructed between about 1820 and 1860 and includes an unusual Greek Revival addition to its rural vernacular farmhouse that perhaps suggests a temple front. Within many rural communities, styles such as Georgian, Federal and Greek Revival were commingled with a rural vernacular style to create a subtle or simpler version of the "high" style of architecture. Plans and designs were found in various publications such as the 1821 Domestic Encyclopedia and as residents prospered economically or saw their families increase, they not only enlarged their existing structures but also updated them periodically in the current styles obtained from the plan books.

History:

Located on the east side of Hanover Pike [Maryland Route 30], south of Manchester, the J.A. Appold House is a rural vernacular farmhouse with a Greek Revival addition. The outbuildings are intact with existing original fabric.

Evaluation:

Constructed circa 1820-1860, this house is not eligible for the National Register of Historic Places. The property is not eligible under Criterion A; no significant events historically or agriculturally have been determined to be associated with the property. The property is not eligible under Criterion B; no persons significant in local, state or national history have been determined to be associated with the property. The property is not eligible under Criterion C; though the house's Greek Revival addition is unusual in perhaps suggesting a temple front, the house and the addition are otherwise unremarkable examples of rural vernacular and Greek Revival-style architecture. Further, numerous alterations have largely compromised the original fabric and form of the house.





DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The J. A. Appold House is located on the east side of Maryland Route 30, on a slight rise in a yard with many trees.

The house faces west to Route 30, and is 2 1/2 stories high, gable roofed, with a gable end facade, which is unusual for the area. It is three bays wide by four, with a one-story open section in the center of the south wall. There is a one story gable roofed extension in the rear. The building is sheathed with white asphalt siding.

The principal facade contains a round arched 2/2 window in the attic story, three 6/6 windows in the second floor, and in the first floor, a central doorway with four-light transom is flanked on each side by a floor length 4/4 window. There are pronounced cornice returns on this facade. A one-story porch extends along this wall and wraps partially around the south facade, supported by new iron posts.

The south facade has a central open space on the first floor; on the second floor, this space is enclosed and contains a doorway and two small square windows. To the west of this central section is a floor length window on the first floor and a 6/6 window above. To the east, the rear section has 6/6 windows, with a small double window on the the second floor. A shed roof porch extends along this rear section of this facade. A one story, one bay deep gable roofed extension, with the ridge of the roof continuing that of the main house, is located in the rear. Outbuildings are located to the east.

This is probably the property shown on an 1877 Lake, Griffing and Stevenson atlas of Carroll County as that of J. A. Appold.

STATEMENT OF SIGNIFICANCE

The Appold House is significant for several interesting features. The gable end facade, with its suggestion of a temple form, typical of Greek Revival architecture, is unusual in the area. In addition, the unusual configuration of the south facade, with its central open space, is suggestive of the two-story galleries more commonly seen in rear ells which are perpendicular to the main block.

However, a similar example of a likely former gallery on the long gable roof facade is the Showers/Yingling Farm (Carr-595), north of Manchester on Route 30. Here, the gallery is in the center of the principal facade.

This open space on the Appold House, and the two bay wide rear east section, with its own shed porch, also suggests that perhaps this rear section was once the original house, which faced south. It was then perhaps extended to the front, when the present west end was added
