DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm is located on the south side of Shiloh Road, west of Hampstead, with open fields and farmland surrounding the complex. The farm contains a house, outbuildings and barn.

The house is in two sections, forming an L-shaped plan. There is a south gable-roofed block of 2 1/2 stories built into a bank and facing south, and a north section of the same height which is perpendicular to it, with its gable end facing Shiloh Road. The house is painted white, and has metal roofing.

The south block has a wooden shed roof porch on its south facade, and an interior west end chimney. It is two bays deep, as is the north block, including the attic stories. The north block has an exterior end chimney, and on its east facade there is a wooden shed roof porch. In the corner between the two sections of the house is a one-story shed roofed addition.

To the southeast is a smaller two story, white, wooden outbuilding, with a gable roof and interior (east) end chimney. To the west area barn and other outbuildings.

This property is probably that of C. Richards shown on an 1862 Martenet atlas of Carroll County.
