### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The farm is located on the south side of Md. Route 482, west of Hampstead, with open fields to the east and woods to the west and south. The complex contains a farmhouse which faces north to the road, with outbuildings located to the rear of the house.

The house is 2 1/2 stories high, sheathed with white siding, and consists of a main block whose gable roof ridge is parallel to the road, with to the rear, a two story shed roof extension with a small one story shed roof addition behind it. The main block is three bays wide by two deep, and has two interior end chimneys, a standing seam metal roof, and a central cross gable.

The principal facade contains one window in the cross gable and three 1/1 windows in the second story. A half-hip roofed porch extends along the first floor of this facade, supported by four wood on brick piers connected by a wooden balustrade.

The east gable end has two 1/1 windows in the first and second story, with two small square four light windows in the attic story. The rear two story extension is one bay deep, with a 1/1 window in each story. The one story shed roof addition has a pair of windows in its east wall. To the south and west are several sheds and small barns.


