DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This large 2 1/2 story frame house is three bays wide by one bay deep, and faces west. Siding is asbestos shingle, with asphalt covering the roof.

The entrance is located in the central bay of the principal (west) facade; a transom and sidelights enhance the doorway. 4/4 sash windows occupy each of the flanking bays, and three such windows are arrayed across the second story, aligned directly above the first-floor openings. A pair of corbeled brick interior chimneys exit from the ridge of the gable roof, defining the central bay. A one-story, half-hipped porch spans the facade.

Both gable facades have a single 4/4 window centrally located on each story, with a 6/6 sash in the peak of the gable to light the attic. A full-height ell, two bays wide, extends to the rear, its north wall continuous with the north gable wall of the main block. An interior chimney appears in the east gable of this ell. A lower, two story, three bay wing - probably an earlier independent structure - extends to the east from the east gable of the ell. This wing is roofed with standing-seam metal. A two-story gallery, its lower story enclosed in frame, spans the rear (east) facade of the main block and the south facade of the ell. The south wall of the east wing has a one-story shed addition.
