DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This site is indicated on Lake, Griffing, and Stevenson's 1877 map of Manchester, as the property of William Zepp. The farmstead includes a large frame bank barn on a stone foundation; the barn's form and proportions are unusual in that it is uncommonly low and wide with an exceptionally deep forebay. The farmhouse, also a bank building, is 2 1/2 stories high, two bays deep; its present five-bay-wide facade is the result of a series of expansions, as its irregular fenestration reveals. The house appears to be of frame construction and is uniformly clad in asbestos shingles, with a standing-seam metal roof. Brick chimneys exit from both gable peaks. Two frame sheds also occur on the site.
