Summary paragraph:

The house is a two story, two bay by two bay frame structure with various nineteenth century outbuildings that were unable to be surveyed due to restrictions.

Description

House (1810-1840)

The Charles Glass House is a two story, three bay by two bay asbestos sided structure identified in the 1980 MHT survey as possibly log. The metal gable roof is parallel to the road with an interior brick chimney on the east gable end. An enclosed porch traverses the south elevation.

Barn (1810-1840)

The two story barn is unique in that its southern gable end is built into a bank. The metal gable roof is perpendicular to the main house and the foldyard is oriented towards the north. A small open shed is attached to the south elevation.

8. Significance

Summary paragraph:

The Charles Glass House is a rural vernacular structure that may be log under asbestos siding. Any original outbuildings have been demolished and the farm's current use is unascertained.

History:

Located on a farm lane north of Water Tank Road, east of Maryland Route 30 and Manchester, the Charles Glass House and barn are all that remain of an early to mid-nineteenth century farm complex. The property is listed on the 1862 Martenet Atlas [owner - J. Herback] and the 1877 Lake, Griffing and Stevenson Atlas [owner - C. Glass].

Evaluation:

Constructed circa 1810-1840, the Charles Glass House is not eligible for the National

Register of Historic Places. The property is not eligible under Criterion A; no significant events historically or agriculturally have been determined to be associated with the property. The property is not eligible under Criterion B; no persons significant in local, state or national history have been determined to be associated with the property. The property is not eligible under Criterion C; the house is an unremarkable example of an early to mid-nineteenth century rural vernacular farmhouse. More significant and intact examples exist within the project area.



DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Charles Glass farm is located at the foot of a hill on the southern edge of a valley northeast of Manchester. It is on the southern edge of a settlement of small farms in this valley. The farm is approached by a long, steep dirt driveway from Watertank Road. The complex contains a house, barns, and sheds.

The house is two stories high, gable roofed, long and narrow in proportions. It has a half-hip roofed, one story porch on its south facade, with small half-size windows above. Probably of log construction, it is now sheathed with white siding. Its present appearance may possibly be the result of additions to the original building.

Near the house, to the west, is a small outbuilding; to the south, along the hillside, is a row of barns and sheds. A particularly good small barn is built into the hillside, and is unusual in that its south gable end is built into the hillside, rather than the barn's longer facade. In the south gable end, is an ornamented, round arched attic window, similar to those seen occasionally on barns in the area.

This may be on the property of Charles Glass shown on the 1877 Lake, Griffing and Stevenson atlas of Carroll County.

STATEMENT OF SIGNIFICANCE

The Charles Glass farm is significant as a 19th century farm complex which also contains buildings of individual interest, especially the house and barn. It is similar to the other small 19th century farmsteads in this valley, and is important as part of this group, which is located in an unusually beautiful and undisturbed landscape.
