Summary paragraph:

The house is a two-and-a-half story, vinyl sided structure with a barn, spring house, sheds and carriage house forming a Linear Mid-Atlantic Layout.

Description

House (1800-1810/1830-1860/1960-)

The main block is 2-1/2 stories, two bays by two bays with vinyl siding and an asphalt shingle roof perpendicular to the road. A wraparound porch with turned wood posts and a collapsing shed roof, extends across the principal [west] facade and the south elevation. Fenestration is irregular with two 6/6 windows on the second story and one 6/6 window and wood/glass entry door on the first story west facade, and no windows on the remaining elevations.

A 2-1/2 story, three bay by two bay addition has been erected on the east elevation of the main block forming a "T". There area six-over-six windows are on all elevations and an asphalt shingle roof with cornice returns is perpendicular to the main block. A 2 story, shed roof addition, two bays by one bay with exterior brick chimney was erected against the north elevation of the main block and the west elevation of the "T" addition. There are no windows on its elevations.

Barn (1860-1880)

The two story frame bank barn with fieldstone foundation is four bays by two bays with a metal gable roof parallel to the road. The barn is located on a slight rise with a ramp that extends from Miller's Station Road. Wood ventilator windows are topped by arched, wood ventilator windows on the north and south elevations and there is a single six-over-six window in the upper level, gable ends. The ramp [west] elevation middle bays have sliding wood doors and a hinged door, the northwest bay has a 6 lite window and small door and the southwest bay a four-over two wood window. A small concrete generator room is located south of the barn.

Outbuildings (1810-1840/1930-)

A 1-1/2 story summer house is located between the farmhouse and barn. Two bays by two bays, structure is sheathed in fish-scale asphalt shingles with a metal gable roof parallel to the road. There is a small porch on the west facade with turned, wood posts and two-over-two windows on all elevations.

A frame chicken house with one-over-one windows and arched surrounds is south of the summer house. The structure is four bays by two bays with a metal shed roof. A

frame carriage house with shed addition and a small 1-1/2 story barn are located to the north of the barn. The smaller barn is two bays by three bays with 6/6 windows and metal gable roof.

8. Significance

Summary paragraph:

The farm complex is representative of a nineteenth century farm complex where the buildings lined one side of the road and the fields were located across the road. The house is a rural vernacular style farmhouse common to the county and the project area.

History:

Located on the east side of Miller's Run Road, east of Maryland Route 30 and Manchester, the Frank Farmstead is part of a small, nineteenth century farming community located on Grave's Run. The farmhouse has undergone extensive alterations but the farm outbuildings and barn are intact examples of a nineteenth century farm complex. The property is depicted on the 1862 Martenet Atlas [owner - J.P. Frank] and the 1877 Lake, Griffing and Stevenson Atlas [owner - Jno. Frank].

Evaluation:

The property is not eligible for the National Register of Historic Places. The property is not eligible under Criterion A; no significant events historically or agriculturally have been determined to be associated with the property. The property is not eligible under Criterion B; no persons significant in local, state or national history have been determined to be associated with the property. The property is not eligible under Criterion C; the farm complex is representative of a small nineteenth century farming community with intact outbuildings. The farmhouse, however, has been extensively altered and has lost its original form and function. There are more intact examples of this type of complex within the project area.




