909 Ridge Road appears to be the Thomas Stevenson farm on the 1862 and 1877 maps. The farmhouse is a two-story, three-bay by one-bay structure with an ell wing. The house contains an excellent example of Victorian-style sawn-wood ornamentation along the roof and porch cornices. The window frames also have excellent trim with their pointed-arch moldings. The site demonstrates a representative mid-to-late nineteenth century Carroll County farm with its picket fence and the location of the barn and other outbuildings.
