11 Cranberry Road is a late nineteenth century farmhouse representative of the style popular during that period in this region. It is a two-and-one-half story, five-bay log two-bay structure built in an L-shaped plan. Ornamentation is found in the centrally-located gable dormer which has a double window with arched tops. The full-length, one-story porch has recently been enclosed.




