DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Seven Springs farm is a rather typical Carroll County dwelling though of frame construction. The house sits a short distance to the north from Flag Marsh Road (Newport Road) with the facade at the south elevation.

This dwelling measures 5 "bays", viz; w. w. d. w. w. with the center door possessing side and over lights and has an "A" plan roof with a small interior chimney at both E. and W. ends. The 3/4 one storey porch at the S. elevation is the typical shed roof design.

all S. elevation windows are 6/6 sash with mouldings, including cornice, of severely plain design.

The most interesting portion of this dwelling is a separate block which, by connecting the two by a small hyphen, gives an overall "H" composition. This rear block is also of two storey height, frame, with an "A" plan roof* and possesses a single large chimney 1/3 the total distance of the roof ridge from the East (interior).

Though of a contrasting cruder design, the latter block appears to predate the first mentioned.
