STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Schaffers Mill Road is in the uttermost NW corner of Baltimore County and is reached by entering either Carroll County or Pennsylvania. The road terminates at Grave Run Road near Lineboro Road. There is a water intake pipe, but the mill has apparently been electrified. The stream is Muddy Creek. The mill was served by the first RFD system radiating out of Carroll County in 1900. Not shown in 1877 atlas. In use as feed mill. (Owner not too friendly) (1967)

The deeds fail to mention the mill. This had been ~~acquired by~~ John List's property before 1849 when he mortgaged it to Henry Stick (B. City L.R. AWB No. 412, f, 421. Subsequent owners were Levi Markel, 1862; Daniel Kreamer of York County; Henry W. Kramer, 1884; Caroline Kramer, 1886; Charles J. Price, 1920; Lawrence A. Raum, 1962; Roy A. Vail, 1970.

Demolished in 1975, according to Mr McGraw. (MEduards 9/22/77)
