DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Freeman-Williams house c. 1850 is a 1½ story three bay by one room frame house with shed addition on the west end. This house is the only structure that remains from the small Mill Community of Back Creek.

The story and a half frame rests on a fully excavated fieldstone foundation and is sheathed with asbestos siding over weatherboard. A medium sloped roof has a composition tile covering. The rear slope continues unbroken to cover the back shed addition.

The main facade is three bays across with a central entrance that is flanked by two 6/6 sash windows the trim is plain. The beaded board door is framed by a plain surround also. A shed porch covers the three openings and is supported by quare posts. The eaves to the roof are slightly ended with the front soffit being sloped.

The south side has an exposed cellar entrance a first floor 6/6 sash and a 2/2 attic light. The shed addition also has windows on the end with a 6/6 first floor window sash and a four pane light for the loft above the kitchen.

The north end has not as many openings. An interior end brick stove stack rises out of the end with two four pane attic lights on either side.

The back of the house has a centrally located entrance with partially glazed door and a single 6/6 sash window to the north. A modern block stove stack was attached to the north end of the shed to heat it.

The interior of this structure was not seen but enough features point to a second to third quarter of the 19th century date. The only other possibility would be that an early structure has been completely redone in the 19th century and only a basic frame remains.

STATEMENT OF SIGNIFICANCE

This frame structure was once part of the Freeman Mill complex that is located on the Lake, Griffing, and Stevenson Atlas (1877) and also appears in old photographs of the area. A number of other structures were here also but have been removed. All that is left of the mill is its race.

The 1½ story house form was undoubtedly used in earlier settlement and this later example shows how the house type was not discarded after years of established settlement.
