The abundance of accessible Cecil County recreational water front property inticed many urban and non-~~resident~~ investors from the mid 19th century onwards. The Philadelphia Long Family were a group of such investors seeking access and property on the Elk River. According to a 1914 plat of ~~this~~ property John Long reserved 32 acres out of Whiteoak Farm which contained the four story wood shingle beach tower, tea house, and carriage house. ~~The plat locates the tower along with the accompanying wharf and bridge from the adjacent cliffs.~~ The unusual shingled tower form is not unlike the popular shingled shapes one finds in Queen Anne architecture of the period. The tea house strengthens the period group with its semi-circular art nouveaü entrance sidelights. The eccentricities of late 19th century fashion and the flexibility of late 19th century architecture have joined to produce a fascinating example of turn of century recreational buildings.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Long Property c. 1905 consists of three frame structures along the shore of the Elk River near Port Herman, Md. The three buildings represent early recreational structures along the tidal Elk River. The most unusual of the three is the combination boat house and residence located at sealevel. The other buildings include a tea house farther up the steep slope and a carriage house on the highest grade.

The boathouse/residence, otherwise known as the "Tower", is a four story one bay by one room shingled frame structure with pyramidal roof. The building faces west. The tall tapering square frame rests on a fieldstone footing. The boathouse is a single story structure with flat deck that is attached to the front of the tower. It is also sheathed with wood shingles and has a large double door entrance through the west wall. The double doors consist of a basic frame with two narrow beaded board flat panels and a X stick bracing. Eight pane lights pierce the top panels and illuminate the interior space. A slightly projecting deck is supported by extended and decorative floor joists.

The west facade of the tower has a different type of window. The second floor has a bracketed hood that projects a six pane light with segmental header. The third floor fenestration consists of three 6/6 sash windows set next to each other while the fourth floor is filled with 6/6 sash with a bracketed cornice molding below the window so as to emphasize the fourth floor. The roof projects out with decorative rafter ends. A small dormer lights the attic on both the west and east sides.

Access to the tower is permitted by a second floor door on the south side of the tower by a catwalk from the steep bank. The entrance like the second floor west window is emphasized by a slightly pedimented hood. The door is flanked by sidelights. The third and fourth floor windows are the same as described for the west facade, as are the north and east sides.

The interior is unfinished in that it has exposed ~~wall~~ studs and ceiling joists. A stair rises from the first floor kitchen to the fourth floor along the east and south walls. Plumbing fixtures, built-in cupboards, and what woodwork is found all date from the turn of the century.

The tea house is built on the westward slope towards the river and is exposed a full two stories on that side. The entrance facade is the east side. The 1½ story frame structure also rests on fieldstone and is covered with wood shingles. A massive exterior stone chimney rises against the south wall. The main entrance is the most unusual feature with its decorative colored glass transom and sidelights that are incorporated into a semi-circle with the door in the center. The colored glass decoration has art novel motifs and character.

The carriage house is a 1½ story three bay by one room shingled frame with hipped roof and cross gables on each roof slope. A porte cochere projects off the south side with a lighted cross gable above. The medium pitched roof has a composition tile shingle covering. The structure rests on a fieldstone foundation. The carriage house has been converted to a single family dwelling which necessitates an eastern single story addition, also with a hip roof. The large entrances have been enclosed on the south side. Two 6/6 sash windows are found on the west side. A small roof projection from the cross gable once held a fully to raise objects to the second floor. Detailing remains basically the same on the other sides of the house. A new block chimney stack has been attached to the north wall.

The interior has been remodeled to suit a living space but a central stair with square newel and balusters does remain as does the horizontal board wainscoting in the kitchen.

A one room square pyramidal roof structure of similar date and construction stands to the east of the house. A pyramidal roofed ventilator tops the structure. 6/6 sash windows light the interior and a four panel door lends access on the west side.

The three buildings are connected by a series of steps from the shore to the tea house with a single bay shed roofed privy along the way. Novelty siding, cast iron decorative grills, and a glass transom liven up the structure.

STATEMENT OF SIGNIFICANCE

The Long Property contains some of the most unusual recreational structures from the turn of the century. The unusual shingled tower form is not unlike the shingled shapes one finds in Queen Anne architecture of the period. The structure is slightly different since it has such an unusual location. The teahouse and carriage house are less of a surprise but also supply interest to this complex.

The present owners of the carriage house are in possession of turn of the century photographs of people at the complex.




