Garrett W. Drennen is listed on both historical county maps and in county tax assessments as owning this two story three bay by one room common bond brick house through the mid 19th century. A slight brick bond variation consists of eleven rows of stretchers for one row of Flemish bond. Other construction features such as the corbelled cornices, extended window lintels, and six over six sash are typical of the second to third quarters of the 19th century.
