George Washington is supposed to have stopped at the brick house next to the Indian Queen Tavern in Charlestown. It is a two story brick house laid in Flemish bond and is five bays long and two rooms deep with an "A" roof. There is a belt course and molded water table on the facade. The windows have 6/6 sash, small frames and appear to have been made narrower than when built. The width of the door appears to be original; it has a rectangular transom. Large chimneys are set within the gable ends and the wood cornice, now only on the two facades, appears to have continued around on the gable ends, forming pent eaves. To the west has been added a brick garage with apartment above.

BRICK MANSION

Lot #82

This house stands on the southeast corner of lot 82 which was drawn at the first balloting for the lots of Charlestown by Capt. Zebulon Hollingsworth who sub-divided the lot and sold this section in 1763 to one Thomas Jacobs, miller. The exact date the building was erected is not known. It was used as a tavern for many years and George Washington stopped here several times on his journeys along the post road from Philadelphia to Mt. Vernon. In 1792, it was sold to Samuel Hogg who resided here until his death in 1826. No major alterations have been done and the house is in almost original condition.

Present owner is Mrs. Margaret Fairlamb.
