The construction of this two and a half story cross-gabled stuccoed fieldstone farmhouse is dated by Mackie ~~family~~ ^{History} and its absence on the 1877 Lake, Griffing, and Stevenson Atlas. Local oral traditions link the erection of this house along with the partial dismantling of ^{the} a Mackie Brother's complex of workers' housing located closer to the Little Elk Creek on Route 273. (CE-72) The expansive view of the Little Elk Valley is an obvious incentive for the construction of a house on this site.
