DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Rising Sun Cemetery Chapel c. 1880 is a 1½ story octagonal frame structure with eight sided conical roof and four single story axial gabled extensions. It forms a Greek cross plan. The cemetery and chapel are on the southwest corner of Rising Sun Town limits which is on the south side of Route 273 and west side of Hopewell Road. The chapel is situated on one of the highest points in Rising Sun and faces east.

The fishscale shingled frame structure rests on a fieldstone foundation and is covered with a peak finial. Eight sided patterned slate roof with protective each gable roof of the extensions are also covered with slate. The eaves are extended and the rafter ends are exposed.

The east (main) facade has a double four panel door entrance through the east projecting gabled bay. The door has a Gothic arch transom which is divided into three smaller Gothic arch panes and a surrounding border of colored lights. Each exposed wall to the right and left of the entrance has a Gothic arch double hung sash with similar format. As one circles the structures every other bay has a gabled projection with a Gothic arch double hung sash between that pierces the main block. The northern bay extension has a corbelled brick stove stack that rises against the end wall. The adjacent main block wall to the west has an exterior basement entrance, along with its identical Gothic sash. The western bay also has a double four panel door entrance with corresponding Gothic arch transom. The central transom light is undivided but still has a border of colored glass. Identical sash lights the other northwest wall and northern gabled extension.

The interior of the structure was not seen but probably contained some traditional devotional materials and possibly late 19th century fixtures. It is unknown how they treated the ceiling; whether it is exposed timber or plaster ceiling.

A circular drive surrounds the structure and late 19th century tombstones naturally fill the cemetery space.

STATEMENT OF SIGNIFICANCE

Cemeteries often contain architectural oddities that do not appear in other contexts. There seems to be more than one and probably many reasons for this occurrence. In the instance of the Rising Sun cemetery, it is more of a town graveyard than one that has association with any particular church. The purchase of the property and decisions related to its final appearance was probably due to a town committee. It appears that the committee's intent was not one of secluded privacy and intimacy for they chose the loftiest hill surrounding Rising Sun. The cemetery's prominence was furthered by the nakedness of the hill and the erection of a towering chapel at the end of the entrance drive. The chapel's height is strengthened by its placement and therefore dominates the hill. Many speculative reasons for this could be proposed. Was this rather unusual structure built to lure people into the graveyard? Did its unusual architectural form help to divert peoples attention from their bereavement?, or, was it an architects chance to experiment?

The structure's hill site, conical shape, and Gothic arches are obvious devices to project a heavenly oriented atmosphere. *thought.* Any other intentions with this structure are mainly conjectural.

This type of architectural form is typical of the Queen Anne shingle style, popular during the 4th quarter of the 19th century. The structure is the only one of its kind in the entire county.


