DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Thompson house c. 1880 is a two story three bay by one room s tuccoed frame house to the east of the Hunt-Bunty house (CE-). The house faces south with an east/west axis.

The two story rectangular frame rests on a full fieldstone foundation and is covered with a medium sloped composition tile roof with extended eaves and sloped soffits. A shorter two story ell kitchen extends to the north from the main block.

The south facade is symmetrically arranged around a central entrance with flanking 6/6 sash windows. A two light transom is found overhead the four panel front door. A shed roof porch covers the three bays and is supported by square posts. The second floor 6/6 sash are directly aligned with the first floor windows.

The east and west gable ends have two 6/6 sash on each floor and two 2/2 attic lights that flank the interior end stove stacks. The west gable end is flush with the west wall of the ell kitchen which is one bay by one room. A single 6/6 sash window lights each floor. The east side is covered with a single story porch addition.

The interior consists of a center enclosed stair with a room to each side. The late 19th Century mantel remains in the west parlor. The thick mantel shelf is supported by six sided pilasters with beveled edges. Four panel doors are framed by late 19th Century stock moldings, the second floor is fairly plain. An enclosed stair rises to the attic.

STATEMENT OF SIGNIFICANCE

The Thompson house does not appear on the 1877 County Atlas. It, therefore, was presumably built after and possibly as a tenant house for the surrounding farm that was owned by Marshall Hunt in 1877. The house type is one that was commonly used throughout the 19th Century.


