DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The C. W. Albertson House c. 1860-1870 is a two story three bay by one room hall/parlor frame house north of Route 273 and east of Rising Sun. The house is situated back a long lane and has an eastern exposure with the main gable running north/south.

The weatherboard frame is covered with a corrugated tin roof and sheathed with imitation composition tile sheathing. The house rests on a partially excavated fieldstone foundation.

The east elevation is symmetrically arranged with a central entrance and corresponding 6/6 sash windows. Three 6/6 sash windows light the second floor and are aligned with the first floor openings. A simple shed roof porch covers the central entrance.

The north and south gable ends have a minimum of openings. Four pane attic lights flank interior end brick stove stacks.

A two story kitchen ell covers most of the west (back) side of the house. It is two bay by one room and has an interior end brick chimney. The south side is covered by a single story enclosed shed addition.

The interior of the front block consists of one large room and a smaller parlor to the south. The parlor has a third quarter of the 19th century mantel on the projecting chimney breast. A molded plaster cornice also distinguishes this room from the more plain details in the hall. A slightly pedimented door surround framed the previous interior doors. The kitchen is also fairly plain.

A delapidated box frame barn stands to the south of the house.

C. W. Albertson seems to have arrived from crowded Bucks County, Pennsylvania in 1868 and purchased land and probably built this house. He is listed on the Patron List as owning 65 acres at the time. The house is a basic form which is found again and again throughout the county.
