DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The McCullough-Ayers House c. 1800-1830 is a two story three bay by one room log house with later two story two bay by one room frame gable end addition, which is south of Barnes Corner Road and southwest of Farmington. The house presently faces north with an east/west axis.

The frame/log house rests on a fieldstone foundation which is partially excavated. The entire house has been sheathed with aluminum siding and the main block covered with a steeply pitched tin and composition tile roof with extended eaves and sloped soffits.

The present main elevation consists of five irregularly spaced door and window openings. The western three comprise the log house. A central entrance is flanked by single pane sash windows. The front door is a later 20th century replacement. Two single pane second floor windows are aligned with the first floor sash. The frame two story two bay addition extends to the east. A door and adjacent sash occupy the first floor openings and two windows light the second floor. The entire first floor is covered by a shed roof porch whose chamfered posts now rest on brick plinths. A slight molded capital adds support to the simple corner brackets. The north slope of the roof is pierced by two gabled dormers with extended and slightly bracketed eaves.

The east gable end of the frame addition is partially covered with a single story gabled addition with shed extensions. An interior end brick chimney rises out of each gable ends.

The south side has a similar fenestration. The door and window surrounds were not replaced and a cavetto molding with inside corner bead completes the surround profile. A partially glazed six panel door also remains with slightly raised panels framed by a thumb molding. The first floor, like the north side is covered with a shed roof porch which has been enclosed on the eastern end to enlarge the kitchen. The remaining chamfered posts have identical corner brackets.

The west gable end has an exterior stuccoed brick chimney stack which replaced the interior chimney pile. Later second floor sash were cut through on either side of the chimney stack. Two 2/2 attic windows also flank the chimney.

The interior has been extensively remodeled according to the present owner since they were responsible for many changes. The box winder and early chimney breast were all removed.

A two story three bay by one room frame tenant house with north and south side shed additions and interior end brick stove stacks stands to the west of the main house. The 19th century agricultural structures have been replaced except for a two story frame granary with side storage bins and a central passage.

STATEMENT OF SIGNIFICANCE

This two story three bay hall/parlor log house with later frame additions stands on part of a tract called "Macedonia", "situate in West Nottingham and bounded on the north by the road leading from Brickley's Smith Shop to the Presbyterian Meeting House." (JS 33/127,1833) John McCullough died intestate while leaving four heirs to inherit the house and 166 acres. The log structure began as a two story three bay house and was enlarged in the mid 19th century by a two bay by one room gable end frame addition. Two gabled 2/2 sash dormers were centered on the entire roof for an united effect. Even later additions extend the house further. Despite almost complete renovation of the log house, its basic form is still apparent. The original two room plan suggests a Scotch-Irish builder, in this case John McCullough.
