

of the house and is not visible from the façade. The windows were probably six-over-six or a similar multi-paned arrangement at one time. Such a small but substantially constructed house was most likely a farm manager's home as part of a once-larger farm property or estate. The house remains in the original location and farm setting as it was originally constructed. The design remains a clear L-plan and retains elements of a small-scale, colonial style vernacular farm house. The good condition of the original structural granite walls reveals the common practice of using native materials and quality workmanship for functional buildings. The association of this house with the surrounding farm outbuildings and the surrounding landscape provides a sense of how a historic farming community appeared before the 1900s. The Walker-Harris-Gutman House conveys design and construction significance and is eligible under criteria C to the National Register of Historic Properties as a fine example of a well-constructed and unique stone vernacular farmhouse with understated Colonial style elements.

RESOURCE SKETCH MAP


