DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Tosh-Williams House c. 1820-1840 is a two story three bay by one room weatherboard hall/parlor plan frame house with later ell kitchen wing to the north. The main facade faces south with an east/west gable axis. The house stands at the end of a long lane off of Liberty Grove Road and just south of Vinegar Hill.

The main house and kitchen wing rest on a rubble fieldstone basement. The house is sheathed with horizontal weatherboards and the siding under the shed porch predates the siding on the rest of the house since it has been covered by the shed porch. A central door opening with six panel door is framed by a beaded surround. The 6/6 sash remains on either side along with three across the second floor and aligned with the first floor openings.

The east gable end is a plain weatherboard wall with a large interior end brick chimney. The eaves are extended but probably done when the roof was re-sheathed.

The west end has a single opening on each floor which appears to be later cut-in openings. An exterior block stack rises against the exterior wall surface and abutts the earlier interior end brick stove stack. Single 2/2 sash windows light each floor and one four pane attic light illuminates the attic exterior entrance allows access to the cellar and an adjacent basement window with diamond cross sectioned horizontal bars helps to light the space.

The rear kitchen wing extends northward one bay and is flush with the gable end of the main block. A single 2/2 sash lights each floor. The gable end also has a single 2/2 sash on each floor along with a two pane attic light. The east end has a side entrance which is covered by a shed roof porch.

An interior inspection was not possible but the owner placed the winder stair in the northeast corner.

Agricultural structures that remain include a medium sized box frame barn with seamed tin roof. A circular wooden silo with conical corrugated tin roof stands on the northeast corner and is held together by circular iron bands. A concrete block dairy and ruinous spring house stand to the west.

STATEMENT OF SIGNIFICANCE

The Tosh-Williams House is a traditional hall/parlor frame house that are spotted throughout Cecil County. The rear kitchen ell appears later and seems to document the movement of kitchen facilities from the basement to a more convenient space behind the house. The house was owned for a major portion of the 19th century by the Tosh family. (Martenet-James Torsh/Lake Atlas - W.A. Tosh) W. A. Tosh appears on the patron list of the 1877 Atlas as owning 25 acres.


