**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Matthew Morrison House c. 1830-1840 is a two story four bay by two room cut and coursed fieldstone house on the southeast corner of the intersection of McCauley and New Valley Roads. The house is situated on the top of a rise with the main facade facing west and the primary gable on a north/south axis.

The house rests on a full fieldstone foundation and is covered by a medium sloped composition tile roof with extended eaves and sloped soffits. A late 19th century five sided frame kitchen is attached to the back of the house and rests on a fieldstone foundation and is sheathed with novelty siding. The pointed five sided seamed tin roof has extended eaves also.

The main elevation is symmetrically arranged with two central door openings and adjacent 6/6 sash windows with louvered shutters. Four identical windows light the second floor and are aligned with the first floor openings. A shed roof porch supported by chamfered posts and corner brackets stretches across the entire front of the house.

The north gable end has two 6/6 sash that light the first floor and two four pane attic lights. Each window opening is supported by a large stone lintel. The windows flank an interior end brick chimney with corbelled cap. The south end wall is a plain stone wall with exterior basement door.

The back (east) side of the structure is laid on a rougher manner as are the end walls. The back was in partially covered by the rear kitchen wing which has been extended to the south by a small single story shed section. One visible 6/6 sash lights the northeast room and three windows pierce the second floor.

The typical room arrangement for houses with two front doors in either a two or three room plan. The structure today is composed of three rooms ~~but one interior wall in the south room was removed and part of it remains along the ceiling.~~ The end wall fireplace has been redone to heat the larger room that ~~now~~ runs the full depth of the main block. The northern half of the house is divided into two rooms of approximately equal size with a small fireplace in the front room. The mantel remains with a fluted molded for a surround which supports molded frieze blocks and finally a slightly beaded shelf. The partially enclosed winder stair rises in the northeast room against the interior wall.

The only questionable aspect of the house is the originality of the four room plan which is not typical of houses with two front doors. The chimney pile against the south wall is supported by a rectangular basement stack support; instead of corbelled corner supports which would have supported the original corner fireplaces if the middle partition was actually original. There is no indication of corner fireplaces on the

first floor either. What appears more logical is the division of the original kitchen into two rooms when the rear frame kitchen was added. The present owners unknowingly removed the middle partition and returned the house to its original plan.

## STATEMENT OF SIGNIFICANCE

The Matthew Morrison house stands on a tract known in the 19th century land records as "Mount Montgomery". The name is certainly appropriate since Harford County is easily seen from this hilltop. One hundred acres of the tract was sold to Matthew Morrison and John Graham (JS 46/8) by Robert and Cornelia Gerry of Philadelphia and Mary Gerry of Cecil County, widow of James Gerry. This finely pointed cut and coursed fieldstone house was apparently built by Morrison and Graham after the 1840 sale. The cross passage/ three room interior retains a large percentage of its second quarter of the 19th century woodwork.
