DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Red brick town house with white paint chipped off is almost square, 3 bays by 2 facing east, 2 stories high, with windows of 2 lights over 2. A side-hall house in plan, the entrance at the south end of the facade has four lights under an ovoid arch below a dentellated cornice or the peaked portico is supported by plain pilasters.

The slate roof has trim eaves, and a boxed and moulded cornice with returns. A brick chimney rises at the north end of the A-frame roof ^{from above} in side the wall. Shutters are missing, paint is peeling from walls and woodwork.
