DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This small frame warehouse with two smaller additions to the north sits beside the Penn Central tracks at the old Rte 1. Tall and narrow in each section, the southernmost part is of clapboard siding, 2 stories high with a tall narrow third floor rising ~~over~~ the ridge line and extending about 7/8ths of the length of the building. This story, housing the grain-elevator machinery, has a window at each end and one in the middle of each long side. Like the main building below it, its roof has a ~~smaller scale~~ gingerbread trim, (but in smaller scale,) at the widely overhanging eaves. The only other decorative element in the building is an arched window under the eaves. Second story windows are shuttered permanently. First floor windows are 6 on 6.
