This frame side-hall house has a stone pattern asphalt covering over the clapboard walls. Almost square, 3 bays by 2, it faces east, 2 1/2 stories, the gable roof ridge line running north-south. A peaked gable in the roof has "gambrel" eaves. Windows have 2 lights over 2 except for ^{the porch windows} on the porch, 2 over 4. The front door has ~~alt~~-lighted transom and 3 lights each side of the door. The front porch has a grape patterned cast-iron trim.
