DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

On the north west corner of Bohemia Avenue and Second Street stands the massive granite Chesapeake City Bank. It is two bays wide and three deep, is one story with a two story entrance tower.

The tower is located on the corner and the entrance is on the east facade and has a semicircular overhead transom over double doors. Between the arch and the three small windows above is a white decorative tin cornice with wreaths on the fascia and a dentil course beneath the crown. The roof of the tower has a plainer cornice (probably replaced) and a hip roof. To the north of the tower is a section of Mansard slate roof with continuation of the cornice mentioned above. An 'A' roof is concealed from this front by this false facade. The cornice continues on both sides of the structure.

Beneath the Mansard roof are double windows with iron grills protecting the 1/1 pane sash. There is a wide Jack arch of granite, like the other windows in the building.

The iron railings which flank the front steps, as well as the plate glass doors appear to be more recent in date than its original construction. A night depository has also been added adjacent the tower.

In front of the building is a large granite monument dedicated to those who fought in the Armed Services. The panel with inscribed names has been removed by vandals.

STATEMENT OF SIGNIFICANCE

Chesapeake City Bank is the only banking building in the town. As was popular during the first quarter of the twentieth century, the building was constructed of heavy masonry to give the impression of great solidity. The building's semi-circular arched door possibly is derived from Richardsonian buildings of the late 19th century, although its cornice is more typical of the Colonial Revival. As the only totally granite building in Chesapeake City, it is significant in itself as in its relation to the neighboring frame structures.

Kendall Cropper acquired this land from the Bayards in 1836. At that time the lot ran all the way to George Street and allowed the right of way for the alley, William Street. John Banks, who has a restaurant and dealt in wines and liquors, owned the property and organized the bank.

The lot on which the bank building stands was transferred in 1903 from John and Elizabeth Banks to the National Bank of Chesapeake City. The granite building was completed in that same year, and has served the community continuously since that time. In 1922, The Elkton Bank and Trust Company bought the real estate and assumed management of the bank. The interior has been remodeled at least twice since 1903.

John Banks was elected Treasurer of Cecil County in 1894 and afterward served three terms as assistant treasurer. After retiring, he organized the bank and served as cashier until his death at age fifty one from choking on a fish bone. John Banks was a successful business man who did much to advance Chesapeake City.






SOUTH CHESAPEAKE

ELKTON QUAD.




