Two stories high, three bays by none, (2 bays x 0 upstairs) the house faces south, a two-story lean to at the west end wall adding 2 bays.

A chimney at the west end of the ~~house~~ ^{peak} ~~ridge~~ of the A-frame roof rises from heating and cooking stoves within.

Two of the three doors are inoperative, (as are several windows) with furniture in front of them. Windows have 6 left over 6.
