STATEMENT OF SIGNIFICANCE

The Getz's are retired store-owners very pleased with their attractive house so near the water, and interested in its history.

One of several houses in town that were burned by the British in 1812 was on this site, rebuilt by 1820 as a one-room house. 3 bays by 10 upper floors were added and the house widened at later dates. Hand-been rafters, pegged, remain in the attic.
