

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The house is a two story, three bay frame dwelling with el. The ridge of the gable roof is on the long axis, running north-south; the gable of the el is perpendicular to that. Principal elevation faces west, the wing attached at the south end of the east wall. There is a one story shed porch on the first story of the west elevation, and another filling in the notch of the "J." at the rear (east) elevation, north of the wing. Windows are generally 6/6. Walls are clapboard.

The barn is a late nineteenth century heavy timber board and batten structure on a rubblestone foundation. The major roof is a gable. The gable of the entrance extension is at right angles to the main roof.

SUBJECT: Buildings at Fair Hill NRMA

There was some confusion over the sites on my list located within the Fair Hill NRMA. I met with Tom Merryweather and Bill and I believe we resolved the problems on my list. The problematic sites are:

✓ CE-562 McMaster Farm. The survey form contains an incorrect map location. The house and barn were located on the site where the equestrian center is currently being constructed. The buildings were demolished in 1982.

CE-771 McCleary House. This map location is wrong and Tom Merryweather believes that the photograph is of a house that is actually in Pennsylvania. There is only one brick structure north of Route 275 in the Fair Hill NRMA.

Cockerham Property. A two-story, three-bay by two-bay house with an L-shaped plan located at the site inaccurately marked as McMaster Farm. See survey form.

J. M. Peterson Farm. A two-story, three-bay by two-bay house with an L-shaped plan located at the site inaccurately marked as McCleary House. See survey form.

Gann Property. A two-story, five-bay by two-bay stone house with a collapsed west wall that is not located on previous surveys. See survey form.



A very large frame house, two storeys high, five bays across the front (west) elevation under a gable roof with a central cross-gable (south). There is a long two storey wing running centrally from the east wall. Windows are generally 1/1, except for the 2/2 attic windows. There is a porch running the length of the west elevation, first storey, with a half-hipped roof with a small central cross gable. The porch roof is supported on four turned posts with a railing of turned balusters. There are elaborate corner brackets at the posts, and the exposed rafter ends of the porch roof are jig-saw cut.

Based on available information the barn located at the Fair Hill Natural Resources Management Area in Cecil County, Maryland is not located within the boundaries of a state listed historic district and does not meet the criteria for individual listing on the Maryland Register. This frame, cross gable structure is constructed on a masonry foundation and is built into a bank with entrances on two levels. Large, thirty six light metal windows divide the side elevations into 6 bays. The structure was reportedly built in 1937 and lacks the architectural distinction to qualify for listing under Criterion C. The property is not known to have any associations with persons or events significant to our past, and thus does not qualify under Criteria A or B. The Department of Natural Resources plans to demolish the structure.


