This excellent log building, once a house, ~~has~~ three bays by 0, 1 1/2 ~~the~~ stories high, dormers in the roof and two windows in the south gable end wall light the second floor ~~rooms~~ offices for the minister.

The stone foundations have been built to house the Sunday-school classes for primary-age children.

The one room on the main floor has fine hand-made paneling at the ~~west~~ north-west end wall around the large brick fireplace. Otherwise interior and Exterior walls have been bared to the logs and refinished inconspicuously.
