Frame construction with clapboards covered with sheet asphalt, the house is oblong 6 bays by 1, two stories high facing east, the pitched roof ridge line running north-south. The roof is of slate. There is one chimney rising along an interior wall, and another inside the south end wall.

Windows have 6 lights on 6.


