This frame 2 story house, with asphalt shingles over clapboard, is L shaped, with a long wing with three doors opening ~~under~~ a ~~first~~ ^{second} story porch supported by brackets 5 spans (6 posts) ~~wide~~ long.

The main house is 4 bays by 2 facing west, the steep pitched roof ridgepole running north-south over wide eaves. A chimney rises inside either end wall. The wing runs east along the north end wall 5 bays by 1.

Windows are 6 over 6 throughout excepting two attic ^{sash} ~~windows~~ in the end wall of the main house, 4 lights, hung ed.
