DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Ingleside Farm is one of the oldest properties in the Perryville area. The farm has been active for over two hundred years. The main house was built in two sections. The front section is stone two stories in height and three bays by three in dimension. The rear section is frame also, two stories in height and two bays by two bays.

The stone section has a gable roof which is very old. The rafters are joined by mortice and tenon and covered with slate. In the east gable is a chimney which has brick supports in the cellar. On both of the gable walls is a projecting line of stone between the second story and the attic. This could have been the watershed for a pent roof. During the late 19th century the exterior walls were coated with plaster and struck to resemble ashlar. Also, at this time, the window frames were changed and caps were added. On the west gable a bay window was constructed on the first floor and a door with a hood supported by brackets on the second floor directly above. The facade of the house had a Victorian era porch built on it, which perhaps replaced an earlier porch. The earliest sash that remains dates from the 19th century and is 6/6.

The walls of this house are two feet thick. The chimney had back to back fireplaces on the first and second floor. The first floor consists of two rooms that had chairrail and wainscotting beneath. This was removed around 1920. Leading to the second floor is a single flight stair with a heavy Victorian newel post at its base. The second floor has been altered over the years and the only woodwork that remains from the 18th century is the paneling that encloses the stairs to the attic. This is constructed of feather edged panels running from ceiling to floor.

The frame (rear) section appears to have served as a kitchen in earlier days. It has a large fireplace and broad chimney. To the north of the house is a very nice stone barn with early board and batten doors with strap hinges. The mortar used to cement the stones has pieces of shells in it.

Down the hill from the house is a two floor combination smoke house and springhouse. It is built of stone against the hill side. One of the doors which is board and batten has rosehead nails in it.

STATEMENT OF SIGNIFICANCE

The Ingleside Farmhouse and outbuildings date from the mid-18th century and early 19th (barn). The ownership of the farm is now clearly established for the early years. It was owned by either the Chew or Jackson family. Handcoer's Map of 1799 shows the farmhouse, but the owner's name is not shown. A mill race from the Mill Creek to the Susquehanna passes between the house and the barn and is reputed to have been dug by slave labor. During the 1850's and 60's, the house is said to have been a stop on the underground railroad.

The outbuildings are extremely important and have been well kept. The house if restored would greatly enhance the setting. This farm is a National Register property.
