The Carmen Frame House is a two-story frame house three bays long by two bays deep. The building has a white tile exterior. The foundation is constructed of uncoursed rubble. A one-story three-bay long porch extends along the facade. There is one centrally located brick chimney. The roof has a galvanized covering. The sash throughout is 6/6. The house has two front doors suggesting that it might have had two families living in it at the same time. Many other buildings in this area have a similar feature. There is a one-story shed extension that stretches along the entire north wall of the building. The roof has a simple box cornice and the original wooden shingles can be seen under the galvanized sheeting.
