DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two-story stone farmhouse which has been stuccoed. The facade has a two-bay front porch with chamfered support posts. It has a gable roof with box cornice and molding. The front entrances each have a transom. The windows have 6/6 sash with plain trim. The second story shutters are louvered while the first are paneled. The bottom of the cornice is made from a single plank 18" wide. There are two inside end chimneys in the central part of the house which have a small 2/2 sash window to either side of them. There is a full cellar under this section with a board and batten door leading to the exterior.

To the rear of the central part of the house is a rear wing with a fireplace in the end away from the house. It has a gable roof with a tin covering over wooden shingles. The door and window frames are pegged and have 2/2 sash.


