DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a rectangular shaped two-story stone farmhouse. It is three bays long by two bays wide. The windows have brick supports over the new 6/6 sash. The door on the facade has a transom. This house has a gable roof of slate with box cornice and barge board. There are two inside end chimneys, one at the east end and the other at the west.

To the north a small stone wing extends. It is two stories and at one time had a large fireplace and chimney. A frame addition has been built to the east of this wing and a garage has been built on the west end of the house.

A frame barn built in the late 19th century has a stone foundation. It was constructed with the use of mortice and tenon and some of the siding is 24" wide.
