DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The small two story, two bay frame dwelling appears to be a twentieth century addition to the streetscape. It is built upon a stuccoed masonry foundation, with piers beneath the leanto screened porch. Between the piers is a checkered lattic. On both storys are two windows and on the first is a central door. The walls are covered with green asbestos siding and the roof with black asphalt. One indication of its recent vintage is the exposed ends of the rafters, which are neither boxed nor shaped. A brick chimney is located in the northwest corner of the structure.




